### TERMS AND CONDITIONS

#### **CONDITIONS OF ENTRY**

1. Information on how to enter, mechanics of entry and the prize form part of these Conditions of Entry. Entry into the competition is deemed acceptance of these Conditions of Entry. Entry is via Internet only. Entry provides the entrant with a chance to win.

#### **COMPETITION PERIOD**

2. The competition commences at 6:00pm (AEDT) on 26/06/2017 and ends at 6:00pm (AEDT) on 2/10/2017 (Competition Period).

#### **ELIGIBILITY**

3. Entry is only open to residents of Australia, aged 18 years or older (Entrants). The directors, management and employees (and their immediate families) of the Promoter, its related entities, printers, suppliers, providers and agencies whom are directly associated with the conduct of this promotion are ineligible to enter the promotion. ## **GENERAL**

16. Entrants can only enter in their own name. Entrants who provide incorrect, misleading or fraudulent information are ineligible to participate in the promotion and all entries of an Entrant who is deemed by the Promoter to have provided incorrect, misleading or fraudulent information may, at the discretion of

the Promoter, be deemed invalid. The Promoter reserves the right to request the Entrant produce (within the requested time) appropriate photo identification or other documentation (to the Promoter's satisfaction, at its sole discretion) in order to confirm the Entrant's identity, age, residential address, eligibility to enter and claim the prize, and any information submitted by the Entrant in entering the promotion, before issuing the prize.
