Representative testing of the Base Oils used to manufacture lubricants shows that they pass IP-346.

#### 11.7 REPRODUCTIVE

TOXICITY:

However, it contains a phenol component that is rated as R62 (Reproductive Toxin Category 3) - Possible risk of impaired fertility, however this is present at amounts of <0.15% in the final product.
